## **Church Qualifier Form**

The Internal Revenue Service used 14 different characteristics to determine whether an organization qualifies as a church. In accordance with this provision, Feeding American Kentucky's Heartland (FAKH) has a policy which requires that any org. which functions as a church must certify that <u>at least nine</u> of these characteristics are evidenced by their program. These characteristics are listed below. <u>NOTE:</u> Each item that your org. checks as a characteristic mush be proven with copies of printed materials from your church, and <u>must be included</u> with your application. Examples of items that your church might use as evidence to satisfy legal requirements are shown below.

1. A distinct legal existence. (Ex.: Articles of incorporation filed with the state.)
2. A recognized creed & form of worship. (Ex.: Cover page & two pages of creed, copy of church bulletin.)
3. A definite & distinct ecclesiastical government. (Ex.: Organization chart of parent organization as well
as local church, indicating names a <mark>nd addresses</mark> of <mark>officials.)</mark>
4. A formal code of doctrine & discipline. (Ex.: Copy of cover and first three pages of document.)
5. A membership not associated with any other church or denomination. (Ex.: Statement of mission,
objectives and goals of the chur <mark>ch signed by</mark> the pastor a <mark>nd three oth</mark> ers.)
6. A distinct religious history. ( <i>Ex.: If <mark>member of re</mark>cognize<mark>d association o</mark>f churches, a copy of church</i>
bulletin. If no associated with oth <mark>er churches, a</mark> brief <mark>written histor</mark> y.)
7. A complete organization of ordained ministers ministering to their congregations. (Ex.: Church bulletin
or other published document listing <mark>ministers.)</mark>
8. Ordained ministers elected after completing prescribed courses of study. (Ex. Appropriate
documentation indicating su <mark>ch ordination a</mark> nd courses of study.)
9. A literature of its own. ( <i>Ex.: Co<mark>py of selected c</mark>over page<mark>s of appropriate</mark> literature.)</i>
10. Established places of worship. ( <i>Ex.: Copy of church bulletin.</i> )
11. Regular congregations. (Ex.: Copy of church bulletin.)
12. Regular religious services ( <i>Ex.: Copy of church bulletin.</i> )
13. Sunday schools for religious instruction of the young (Ex.: Copy of church bulletin indicating times of
Sunday schools.)
14. Schools for the preparation of its ministers. (Ex.: List of names and addresses of schools.)
